
SUBJECT: Memorandum of Agreement for Army SROTC for Lyon College.

1. Purpose: The purpose of this memorandum is to provide for enrollment of students from the cross-town institution, Lyon College, in the host institution, Arkansas State University – Jonesboro's, Army Senior Reserve Officers' Training Corps (SROTC) Program.
2. General:
 - a. The US Army has an agreement to provide Army SROTC instruction at Arkansas State University (the Host Program), see enclosure 2. Copies of this agreement (DA Form 918A) are on file at Arkansas State University and Headquarters, U.S. Army Cadet Command.
 - b. The Army SROTC program will provide SROTC instruction and training for qualified students enrolled from Lyon College on the same basis as for students enrolled in SROTC at Arkansas State University. The terms and conditions set forth in Arkansas State University SROTC agreement are applicable to Lyon College.
 - c. Lyon College agrees to authorize its students to enroll in and attend Army SROTC classes offered at Arkansas State University.
 - d. Lyon College will provide grade reports and transcripts of SROTC students to the Army SROTC program, as required, to monitor student academic performance per Army Regulation 145-1.
 - e. Lyon College will accept the grades awarded by the Army SROTC program for inclusion in the student's official grade record/transcript and grant appropriate academic credit applicable toward graduation for the successful completion of SROTC courses.
 - f. Lyon College students enrolled in SROTC program are responsible for making their own arrangements for transportation to and from the Arkansas State University for those SROTC activities requiring their attendance.
 - g. Lyon College agrees that no SROTC unit will be established or maintained at a school that unlawfully discriminates with respect to admission or subsequent treatment of students in a manner prohibited under applicable state and/or federal law, and applicable federal regulations and other policies.
 - h. Lyon College will comply with applicable federal and state law and Department of Defense (DoD) policy prohibiting discrimination based upon race, color, religion, sex (including gender identity), sexual orientation and/or national origin. No ROTC unit will be established or maintained at a school that unlawfully discriminates in a manner prohibited under applicable federal and state laws and DoD policy with respect to Military Service members and federal employee civilian staff to the ROTC unit; this prohibition applies to any requirements regarding

the status, privileges or benefits accorded to such persons under law, DoD policy, state or school policy.



ENCLOSURE 1 TO MEMORANDUM OF AGREEMENT BETWEEN THE U.S. ARMY,
ARKANSAS STATE UNIVERSITY AT JONESBORO, AND LYON COLLEGE AT BATESVILLE

SUBJECT: Supplemental Considerations for the SROTC program.

1. Supplemental considerations identified for the US Army SROTC program and Lyon College.

a. The US Army agrees:

i. To provide military instructors from the host program at Arkansas State University at Jonesboro and/or the extension unit at Arkansas State University at Beebe as necessary for the proper administration and conduct of the Army SROTC program. The decision to provide SROTC instruction will be based on the most efficient allocation of limited resources (e.g. manpower) to meet the specific needs of the Army (DoDI 1215.08, para 3.1).

ii. To issue, subject to the availability of funding, at the expense of the U.S. government, uniforms, and equipment required for students enrolled in the Army ROTC at Lyon College. Title of these items remains with the U.S. government. Non-enrolled students participating in ROTC classes will be provided instructional material.

b. Lyon College agrees:

i. To address and provide, to the extent possible, the needs for academic instruction, classroom, office space and adequate storage space along with automation support in order to train the cadets properly.

ii. To authorize its students to enroll in and attend ROTC classes through Arkansas State University until such time as Lyon College can offer each Military Science Leadership (MSL) course through their course catalog offerings. The class location will be at Lyon College and Leadership Labs conducted at either Lyon College or at a practical field location as determined by the Assistant Professor of Military Science.

iii. To recognize the Senior Military Officer assigned to Arkansas State University as the Visiting Professor of Military Science at Lyon College and all ROTC Cadre as visiting members of Lyon College Faculty. As visiting faculty, the ROTC faculty are expected to conduct themselves in accordance with the highest standards as exemplified in the Army values.

iv. To include all Military Science courses in the Lyon College Bulletin as well as the schedule of classes. The number of credit hours for each course will be equivalent to the credit hours offered by the host institution.

v. To require its students to return all government uniforms, books and equipment upon disenrollment or upon completion of the course. To provide for the protection of all public property used in support of the ROTC program and to take all reasonable measures within the power of Lyon College to recover U.S. government property which is improperly in the hands of students or former students. This will include the withholding of transcripts of students or former students who fail to return government property upon disenrollment or at the conclusion



of their course of ROTC instruction. Lyon College shall not be liable for the loss of or damage to public property used in support of the ROTC program.

vi. To assist in recruiting students for the program by affording ROTC instructor personnel the opportunity to communicate directly with individual students and faculty members in connection with Army ROTC and ROTC recruiting.

vii. To ensure equal representation for ROTC personnel during recruiting, enrollment, counseling, course scheduling, financial assistance and other student-oriented actions by the administration and faculty.
